DRAFT AMENDMENT – DEFINITION OF ACTIVE DAM

3. ACTIVE DAM LISTS AND CALF ENTRY FORMS:

- (a) An Active Dam List, (ADL) is sent to each Breeder Member annually. This should be correctly completed and must be forwarded to the Registrar of the Society by 31 August each year.

 A pre-printed Calf Entry Form is sent to each Breeder Member annually. This should be completed accurately, including all calves dead or alive, sire of calves and all dry cows.
- (b) The ADL pre-printed to show all breeding cows aged 2 years and over which the Society believes are currently active in your herd.

An Active Dam is any registered cow or heifer 18 month or older as at 30th June in the the year the ADL is produced, which the Society believes is currently active in your herd.

For example, the Active Dam List for 2014 shall include all cows and heifers 18 month or older as at 30th June 2014, which the Society believes are currently active in your herd.

A Breeder may advise the Registrar by 31 August in any given year, of any Active Dams that they wish to declare inactive for the subsequent period.

An Inactive Dam is still registered but must be re-activated before any calves from that dam can be registered or before that dam can be transferred.

Alan Moved these Amendments, Seconded Barry. Carried.

- Alan brought up for discussion to avoid confusion that the word "Standards" be used to describe "Standard Galloways". There was a general consensus to the status quo would prevail.
- Rule 6.3. The rule contradicts itself in its intention. Barry was of the opinion that continuity
 was an important factor to consider when a council was elected perhaps only a certain % over
 9 years. It was suggested that having a person on for longer than 9 years could be a problem
 however if that is the case, that person can be voted off democratically.
- Rule 13.9 to be revisited at another meeting.
